### RESOLUTION 2022-07

The Board of Trustees of Miami Township, Clermont County, Ohio met in regular session at the Miami Township Civic Center on March 22, 2022, with the following members present: Mary Makley Wolff, Mark Schulte and Ken Tracy.

A motion was made to adopt the following Resolution:

#### **RESOLUTION AUTHORIZING THE USE OF UNDER-SPEED GOLF CARTS ON STREETS AND HIGHWAYS WITHIN THE TOWNSHIP AND DISPENSING WITH A SECOND READING.**

**WHEREAS**, the Board of Trustees (the “Board”) is aware that the use of under-speed golf carts on Township streets has become more prevalent and members of the community have expressed the desire to legally operate them on certain streets and highways in Miami Township (the “Township”); and

**WHEREAS**, Ohio Revised Code Section 4511.214 authorizes the Township to permit and regulate the use of under-speed golf carts, on streets and highways within the Township; and

**WHEREAS**, Ohio Revised Code Section 4511.215(b) permits the Township to establish additional requirements for the operation of under-speed golf carts on its streets and highways.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Miami Township, Clermont County, Ohio by authority of Section 4511.214 of the Ohio Revised Code, as follows:

**SECTION 1:** The Board of Trustees hereby authorizes the use of under-speed golf carts operation on all streets and highways in the Township with a maximum speed limit of twenty-five (25) miles per hour or less, provided the vehicle be operated by a licensed driver, properly inspected, and comply with all other requirements under Ohio law.

**SECTION 2:** All under-speed golf carts being operated on streets and highways in the Township must comply with the inspection requirements established by the department of public safety under Section 4513.02 of the Ohio Revised Code.

**SECTION 3:** That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Resolution shall take effect at the earliest period allowed by law.

The motion was seconded, and the resolution was adopted.


