A RESOLUTION AUTHORIZING THE APPROVAL OF A LEASE AGREEMENT WITH LAWRENCE J. WOOD II AND ALL AROUND JOE, LLC AND DISPENSING WITH THE SECOND READING

WHEREAS, Miami Township, Clermont County, Ohio (the "Township") is the owner of the building and real property located at 5859 Wolfpen Pleasant Hill Road in Miami Township, Clermont County, Ohio (the "Property"); and

WHEREAS, The Township has been leasing the Property to Lawrence J. Wood II and All Around Joe, LLC and now seeks to enter into a new written agreement with them related to the Property.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Miami Township, Clermont County, Ohio as follows:

SECTION 1: Pursuant to Ohio Revised Code Section 505.10, the Township has the ability to sell, lease or transfer real property.

SECTION 2. The Board does hereby authorize the Township Administrator Administrator/Public Safety Director to enter into a written Lease Agreement for the Property with Lawrence J. Wood II and All Around Joe, LLC for a two year period with the option to extend (the "Lease Agreement"). A copy of the Lease Agreement is attached as <u>Exhibit A</u> and incorporated herein by reference.

SECTION 3: The Board does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.

SECTION 4: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
